

The privacy policy of our company Knowledgepro education Sickla AB's ("Knowledgepro"), organisation number 556902-4176.

Knowledgepro values personal integrity and the protection of personal data. This means that Knowledgepro strives to only process personal data when necessary for specifically set goals. The General Data Protection Regulation (GDPR), protects an individual's personal data. In the text below, you will find an overview of how Knowledgepro processes personal data, what rights you have if we as a company process personal data about you, as well as information about where to turn if you have additional questions.

# **Responsible Controller**

Knowledgepro education Sickla AB, organisation number 556902-4176, is the responsible data controller for the company's processing of personal data.

### **Data Processors**

In some cases, data processors may be used, i.e. companies that process personal data on Knowledgepro's behalf. When a data processor is being used, Knowledgepro will always before processing ensure that there is a set agreement between the parties that regulates how the data is to be processed.

## **Location of the Data process**

Knowledgepro strives to process all personal data within the EU/EEA. In cases where personal data is processed outside the EU/EEA, Knowledgepro will take necessary steps to ensure the level of protection meets the requirements set in GDPR and relevant national legislation. This means that actions such as using the EU Standard contractual clauses ("SCCs") and working through recognized organizations.

## Security

Knowledgepro protects personal data in multiple ways such as, antivirus protection, firewalls and minimizing data access. In addition, encryption is used to protect sensitive data. Knowledgepro is constantly working to maintain and improve the security of our IT environment.

### How long do we save personal data?

Knowledgepro never saves your personal data longer than what is necessary for each purpose. See the specified purposes for information how long personal data is stored in regard to that purpose.

### **Data subject rights Right of access**

Knowledgepro strive to always be transparent with how we process personal data. For a deeper understanding of what personal data Knowledgepro is processing regarding you, please contact us for a copy sheet of your personal data as well as other supplementary information.

# Right to rectification

In case any of your personal data that is being processed at Knowledgepro is inaccurate or incomplete, you always have the right to request that we correct or supplement the data.



## Right to be forgotten

You have the right to request that we stop processing personal data concerning you in the following situations:

- the personal data is no longer necessary in relation to the purpose for which they were collected or processed;
- the process was based on consent, and you withdraw your previously given consent;
- the data is being processed based on legitimate interests pursued by the controller and you object to those interests; or
- the data is being unlawfully processed.

Knowledgepro has the right to deny your request if there are legal obligations that prevent us from immediately deleting your personal data. These obligations may be such as, mandatory legislation. It may also be that the treatment is necessary for us to determine, enforce or defend legal claims. Should we be prevented from deleting the personal data, we will instead block it from being used for purposes other than those preventing the requested removal.

# Right to restriction of processing

You are entitled to request that we limit our processing of your personal data. If you have an objection to the accuracy of the personal data we provide, you may request that the process is limited until Knowledgepro confirms the accuracy of the data. If we no longer need your personal information for the specified purposes, but you need them to determine, enforce or defend legal claims, you may request limited processing from Knowledgepro, meaning you can request that we do not delete your information during that period. If you have objected to a process based on legitimate interest, you may request that treatment be limited during the time need to check if Knowledgepro legitimate interests outweigh your interest of getting the data deleted. If a process has been limited in accordance with any of the above situations, we may only process the data to determine, enforce or defend legal claims, to protect someone else's rights or if you have given your consent.

## Right to data portability

If Knowledgepro right to process your personal data is based on consent or performance of a contract with you, you are entitled to request the information related to you, which you have provided to us, is transferred to another data controller (so-called data portability). A prerequisite for data portability is that the transfer is technically possible and can be done automatically.
